ASME 'U' AND NBBI 'R' STAMP CERTIFICATION

The ASME 'U' stamp: Certifies that a manufacturer meets the quality control system requirements laid out in the American Society of Mechanical Engineers (ASME) Boiler and Pressure Vessel Code (BPVC). Manufacturers with this stamp are permitted to design, fabricate, inspect, and test pressure vessels.

The NBBI 'R' Stamp: Is awarded by The National Board of Boiler and Pressure Vessel Inspectors (NBBI). It allows the recipient to repair and alter pressure-retaining equipment, including pressure vessels and boilers.
